## **DIVISION I**

### **CONTENT APPLICABLE TO EACH PROFESSIONAL ORDER**

**1.** The roll of a professional order is titled “Roll of the (name of order)”.

**2.** The roll of an order contains for each member, in addition to the information required by the Professional Code (chapter C-26),

- (1) mention of the fact that the member’s permit has already been revoked; and
- (2) the sector of practice in which the member principally practises.

For the purposes of this Regulation, “sector of practice” means the sector of activity or the area of practice, or a combination of the two.

## **DIVISION II**

### **CONTENT APPLICABLE TO CERTAIN PROFESSIONAL ORDERS**

**2.1.** The roll of the Ordre professionnel des agronomes du Québec contains for each member the member’s number.

**3.** The roll of the Ordre professionnel des chimistes du Québec contains, for each member, the year in which a professional inspection was conducted of the member.

**4.** The roll of the Ordre des comptables professionnels agréés du Québec contains for each member the name of the assignee of the member’s records.

- (1) the name of the assignee of the member’s records;
- (2) the number of the member’s public accountancy permit;
- (3) a note to the effect that the member’s public accountancy permit is or has already been suspended or has already been revoked; and
- (4) an indication of the limitation related to the member’s public accountancy permit issued in accordance with section 65 of the Chartered Professional Accountants Act (chapter C-48.1).

**4.1.** The roll of the Ordre professionnel des dentistes du Québec contains for each member

- (1) the name of the assignee of the member’s records; and
- (2) the member’s number.

**4.2.** The roll of the Ordre professionnel des diététistes-nutritionnistes du Québec contains, for each member, the member's number.

**4.3.** The roll of the Ordre professionnel des ergothérapeutes du Québec contains, for each member, the member's number.

**5.** The roll of the Ordre professionnel des infirmières et infirmiers du Québec contains for each member

(1) the main functions of the member;

(2) the level of service of the professional activities engaged in by the member;

(3) the number of hours during which the member practised from 1 January to 31 December of the year preceding the member's entry on the roll; and

(4) the member's number.

**5.1.** The roll of the Ordre professionnel des ingénieurs du Québec contains for each member the member's number.

**7.** The roll of the Ordre professionnel des médecins du Québec contains for each member

(1) the name of the assignee of the member's records; and

(2) the member's number.

**7.1.** The roll of the Ordre professionnel des notaires du Québec contains for each member

(1) the member's fax number at work;

(2) the name of the assignee, provisional custodian and depositary of records; and

(3) the name of the person authorized to issue a copy of or extract from the member's deeds.

**9.** The roll of the Ordre professionnel des technologues en imagerie médicale, en radio-oncologie et en électrophysiologie médicale du Québec contains for each member the member's number.

**9.1.** The roll of the professional orders referred to in the first paragraph of section 187 of the Professional Code (chapter C-26) contains for each of their members holding a radiology permit a note to the effect that that permit is or has already been suspended or has already been revoked.

**9.2.** The roll of the professional orders referred to in the first paragraph of section 187.1 of the Professional Code (chapter C-26) contains for each of their members holding a psychotherapist's permit

(1) the date of issue of the permit;

(2) a note to the effect that the member's permit is or has already been suspended or has already been revoked; and

(3) a note to the effect that the permit holder's right to practise psychotherapy is or has already been restricted or suspended.

**9.3.** The roll of the Ordre professionnel des denturologistes du Québec and the Ordre professionnel des technologues en prothèses et appareils dentaires du Québec contains for each of their members holding a dental prosthesis laboratory management permit a note to the effect that that permit is or has already been suspended or has already been revoked.

**9.4.** The roll of the Ordre professionnel des optométristes du Québec contains for each member

(1) the member's number;

(2) a note to the effect that the member's permit referred to in the first or second paragraph of section 19.2 of the Optometry Act (chapter O-7) is or has already been suspended or has already been revoked.

**10.** The information referred to in this Division is complementary to the information required by Division I and the Professional Code (chapter C-26).
